

## PRIVACY POLICY

Xbt.club respects the privacy of its users and is committed to protecting their personal information and using it properly. This policy defines how we may collect and use personal information as well as the rights and choices available to the users and visitors of our site regarding this information. We urge our users to read the policy carefully and make sure that you understand and agree with it before accessing any of our services.

### 1. Your Consent (please read carefully)

This policy is a binding contract between Xbt.club and you so please read it carefully. You may visit and/or use the services only if you fully agree to this Privacy Policy and by accessing any of the services, including the processing and collecting of your personal information as defined and explained below.

Please Note: You are not obligated by law to provide us with any information. You hereby acknowledge, warrant and agree that any information you provide to us is with your own free consent and will, for the purposes and uses described therein.

### 2. Information We Collect

We collect two types of information regarding our visitors and users:

1. Un-identified and non-identifiable information This information may be made available to us or collected automatically via his/her use of the services. This Non-Personal Information mainly consists of technical and aggregated usage information, such as visitor's and user's browsing activity on the services, scrolls, non-identifying information regarding the visitor's or user's device, operating system, internet browser, screen resolution, language and keyboard settings, internet service provider, exit pages etc.
2. Personal Information This information collected by us may with reasonable efforts cause the identification of an individual, mainly consisting of his contact details (email address or phone number), billing details (name, physical billing address, payment method and transaction details), browsing or usage session details (IP address, geographical information and device unique identifier), third party accounts details (email or username for a connected PayPal, Google or Facebook account), scanned identification documents provided to us (ID card, driver's license, passport or official company registration documents), correspondences (those made through or uploaded to our services) and any other personal information provided to us by visitors or users through the access to our services. For the avoidance of any doubt, any personal information that is connected or linked to being considered as personal information (in order to improve the services we offer) is deemed to be treated as personal by us as long as such linkage or connection exists.

### 3. User's of the User's information

You may collect, store and process certain non-personal and personal information of users-of- users on our user's behalf and at their direction (the users are able to import their email contacts from third party services like Gmail or collect and manage contacts via their user website which are then stored by Xbt.club on the user's behalf).

In such cases or situations, the users controlling and operating such user websites shall be considered as the controllers of such users- of-users information and are responsible for complying with all the rules and regulations that may apply to the collection and control of such information. We advise our users to publish and maintain clear and comprehensive privacy policies on their user websites in accordance with the applicable rules that all users-of- users carefully read those policies and make sure they agree to it.

For visitors, users and customers: Xbt.club has no direct relationship with the individual users-of- users whose personal information it processes. If you are a visitor, user or customer of any of our users and would like to mail any requests or queries regarding your personal information, please contact the user directly.

#### 4. Confidentiality and Security:

Data transmissions over the internet are not 100% secure so we cannot guarantee the security of any information you transmit to us and you do so at your own risk. We make reasonable efforts to ensure security on our systems through physical, electronic and procedural safeguards to protect the personal information about you. Your account information is password-protected but this is not a guarantee that such information may not be accessed, disclosed, altered or destroyed by breach of a firewall. However, if Xbt.club learns about such occurrence we may notify you electronically so that you can take appropriate protective steps.

#### 5. Age Restricted

The service is not directed to persons under 18. We do not knowingly collect personally identifiable information from children under 16. In case a parent or guardian becomes aware of the fact his/her child has provided us with their personal information without their consent, he/she should immediately contact us at [https://www.Xbt.club/#contact\\_us](https://www.Xbt.club/#contact_us) Once the information is brought to our notice, we will delete such information from our files.

#### 6. Access to Personal Information

If you wish to access or request us to make corrections to the Personal Information that you have stored with us (either yours or your users-of users), or wish to request a list of what personal information pertaining to you we disclosed to third parties for direct marketing purposes, you can mail us at: [https://www.Xbt.club/#contact\\_us](https://www.Xbt.club/#contact_us) and we will respond within a reasonable time frame.

#### 7. Data Retention

We may retain your personal information as long as your user account is active or as needed by us to provide you with our services. We may continue to retain such information even after you deactivate your user account and cease to use any particular services, as necessary to comply with our legal obligations, resolve disputes regarding our users or their users-of users, prevent fraud and abuse, to enforce our agreements and protect our legitimate interests.

#### 8. Links to Third Parties

Our site may contain links to other websites, online services or applications. The fact that we link to a third party service is not an endorsement, authorization or representation of our affiliation with that third party nor is it an endorsement of their privacy or information security policies. Online services and websites follow different rules and regulations regarding the use or disclosure of the personal information you provide to them. We do not exercise any control over their services and highly recommend that you read the privacy policies of the third parties you visit before submission of any personal data to them.

#### 9. Cookies and Tracking

We use some monitoring and tracking technologies like cookies in order to maintain, provide and improve our services to facilitate our users and their users-of- users with a better experience. However, every time you visit a third party link or services, they may place cookies or use other tracking technologies through our services. Third party links have their own policies for collecting and storing information. These practices are not covered by our Privacy Policy and we do not have any control over them.

#### 10. Social Media Features and Framed Pages

Our services include some social media features like Facebook Connect and Google Sign-In features. These social media features may collect information like IP address or which page you visit on our website. They may set a cookie to help them function properly and are hosted by either third party or directly on our services. Our services may enable you to provide your personal information to third parties directly. However, please note that if you choose to do so via such frames, then you are sharing it with those third parties and not us and such interactions are controlled by those third party policies and not us.

#### 11. Facebook Login, Google+

You can log in to our service using sign-in services like Facebook Login, Google+ or an Open ID provider. These services will authenticate your identity and ask you to provide some personal information such as your name and email address in the sign up form. You should learn to control how your information is shared on your Google+ profile.

#### 12. Law Enforcement, Legal Requests and Duties

Xbt.club may disclose or allow others access to your personal information in regard to a legal request such as legal proceedings, search warrant and court order or in compliance with applicable laws if we feel that the law requires us to do so, with or without any prior notice to you.
